2. EJF and Friedman may be deemed to beneficially own the 503,855 shares of common stock owned by Distressed Fund, and the 286,954 shares owned by Kodiak. Each of the reporting person, Friedman, Distressed Fund and Kodiak disclaims beneficial ownership of such 790,809 shares of common stock, except to the extent of its respective pecuniary interest, if any, in such 790,809 shares.
